Delaware County: 2 levies for one year. For siren system:

Delaware County voters will be asked to approve two levies on the Nov. 3 ballot that would fund and maintain a countywide emergency siren system. The county commissioners voted 3-0 Aug. 17 to send the two levies to the ballot. The levy to construct the system would be 0.4-mill, while a maintenance levy would be for 0.1-mill. Each would be collected for only one year. Combined, the levies would cost a homeowner \$15.31 per \$100,000 of valuation, said Brian Galligher, director of the county's emergency management agency. Included in the ballot language is a commitment by the commissioners to buy any existing siren systems that other governmental entities have installed in the city of Delaware, Scioto Township, and the villages of Galena and Sunbury, said commission president Tommy Thompson.
